Notice is hereby given of the joint public participation process in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (NEMA), as amended, and the National Environmental Management: Air Quality Act (No. 39 of 2004) (NEM:AQA).

The proposal is to construct a Liquified Petroleum Gas (LPG)-to-power facility generating up to 300MW of power, an overhead electricity transmission line and associated pipeline infrastructure on various farm portions in Saldanha. It is proposed as a bid response to the Request for Proposal issued by the Department of Mineral Resources and Energy (DMRE) under the Risk Mitigation Independent Power Producer (IPP) Procurement Programme. Refer to **Appendix A** for a locality map.

Application for Environmental Authorisation and an Air Emission Licence will be made for the following activities:

Atmospheric emission activities: Activity 1.4 (GN No. 893, as amended)

These activities necessitate a Scoping and Environmental Impact Assessment process (S&EIA) to apply for the requisite environmental development rights. Note that the proposed activity may also trigger Section 21 (c) and (i) of the National Water Act (No. 36 of 1998), however this will be confirmed through the S&EIA process.

Chand Environmental Consultants has been appointed by the applicant to undertake the necessary environmental process. This advertisement therefore serves the following three purposes:
