3. Approval of previous Minutes (8th PAF Meeting held on 31 May 2019)

➤ The minutes of the 8th Public Advisory Forum Meeting were accepted by the meeting, approved and signed by the Chairperson (AK).

4. Matters arising from previous meetings

- On 11 June 2019, DPW authorized Sea Harvest, via email (whilst Concessionary Agreement is being finalized) to proceed with the installation of the dispersion line on the Government Jetty.(C)
- CvW is of the view that an EIA application may have had to be followed, to include Added Value waste stream. FH will follow up with DEA/DEADP (OS)
- On 16 August 2019 Sea Harvest received a draft amended permit from DEA, in respect of amendment applications made on 09 July 2018 & 27 August 2018 for:
 - three effluent streams (FFP, AV & RO brine) to be discharged at a common point on the Government Jetty
 - -an increase in abstraction and discharge volumes.

- The meeting requested that the External sampling report indicate parameters as well. (OS)
- AK enquired as to DEA's satisfaction with Sea Harvest's CWDP compliance. E-mail request was addressed to DEA on 25 January 2019. Still awaiting feedback (OS).

5. New Matters

- ➤ ME gave a presentation on the Sea Harvest CWDP performance for the 9th quarter
- > Sea Harvest submitted its 8th quarterly report to DEA on 26 June 2019.
- ➤ A Gantt chart was submitted to DEADP on 20 June 2019 to track Sea Harvest Desalination Plant progress and dispersion line installation on the Government Jetty.
- > Sea Harvest started with the excavation on the Government Jetty on 13 August 2019 for the installation of the dispersion line.
- CvW requested that Sea Harvest include CWDP presentation when circulating the minutes.
- CS suggested that Sea Harvest engage with Improchem and obtain an opinion iro Chemical Oxygen Demand and Ammonia Nitrogen results.

- Progress report update in respect of Section 30A for the RO Plant to SBM was done on 20 June 2019.
- ➤ A quarterly report update to be communicated in respect of the Dispersion line installation on the Government jetty to DEADP & SBM and is due on 26 September 2019.
